2. YOUR SOCIAL SECURITY

and Alien Registration # if you're not a US resident



3. DRIVER'S LICENSE

not required if you don't have one



4. TAX RETURNS & W-2S

Last year's tax returns, and your parents' if you are a dependent



5. BANK STATEMENTS

Cash, checking, savings, money markets, and the like



6. ASSETS

Stocks, bonds, investments, real estate, etc.

FYI

No need to report family home, retirement accts, or small, family-owned business



7. UNTAXED INCOME

Child support, interest income, gov't issued benefits, etc.



8. LIST OF SCHOOLS

Include all you plan on applying too, even if not accepted yet



9. 60 MINUTES

Once you've gathered all your paperwork, expect the FAFSA application to take about an hour
